




# **1** Introduction



## 02.1

### /Preface



2007 was a transitional year for the European Union. During this year the Union faced several difficulties and went through a period of skepticism. As a young person I felt frequently the threat of insecurity. A substantial question was raised that preoccupied the young generation of Europeans: Does the European Union represent what we have learned in our academic books all these years?

Our generation was brought up with the knowledge that the European Union has been in progress for 50 years now. We believed that the unique structure that we call the European Union is the best example of cooperation and compromise for our common future. But suddenly clouds came to shadow this dream. The rejection of the Constitutional Treaty was a big blow to the stability of the Union. The European citizens felt that they could not trust anymore the European Union as a guide for the forthcoming years.

At that time the European Union needed the leadership which would drag us out of the crisis and give hope for the future. The leaders of Europe, especially those of EPP - decided to make an additional effort to reach a new agreement. It was not easy but the belief in this structure provided the motivation for compromise again. This compromise is called the Lisbon Treaty. As the President of YEPP, I can promise that our organization is going to be in the front line in this fight. YEPP is a pro-European organization. In its 10 year history YEPP is always present fighting for the future of Europe - our common future.

YEPP in 2007 made important decisions regarding the future. At the beginning of the year we tried to prepare for reforms. We undertook a financial reform in order to give YEPP the opportunity to solve financial problems that existed or could appear in the future. At the same time we needed to decide on the main topics that concern our generation and form a political agenda for the term 2007-2009 which will drive us to the next European elections. In May both of these projects were voted in our 6th Congress in Stockholm. In this Congress we voted on the base of financial stability for YEPP and my board was provided with its core political program for the future.

This Congress was the beginning of a period of serious political work for our organization. YEPP is the biggest youth political European organization and must influence the decision makers. Our voice must be heard loud enough in every room in Europe where decisions are being made. That is our target and under these conditions we are working. We believe in the European Union and we will use all our efforts to further progress. We need to convince the leaders that they must provide our generation with a stronger Europe, a real political Union.

From the beginning of this mandate, we engaged in a discussion on the climate change where we presented our own proposals in Croatia in September, we had a constructive debate on demographical challenge in Slovenia in December and we are continuing with our efforts. We will be ready at the end of 2008 to present our proposals on the most important issue for young Europeans and - we want YEPP to have an active role at the campaign for the next European elections.

YEPP is an organization with the most active and experienced young politicians. Our aim is for this group of very different people - who come from all over Europe- to combine their political thoughts in such a way that will provide YEPP with ideas that will recommend new proposals to the European Union. YEPP must be the vehicle that will drive our dreams into reality. YEPP is a unique chance for young people to put a small piece to the puzzle of the European Union. It is our decision how we are going to use it!

This Yearbook is a summary of what YEPP achieved in 2007. By just having a look you can understand what YEPP is about. We want to communicate to the readers the spirit of our organization. Nevertheless a book cannot replace the reality thus, I invite you to come and enjoy the unique experience of YEPP meetings. At last, I would like to thank all the young activists who follow YEPP, all the people who have contributed to this Yearbook and also the Constantinos Karamanlis Institute for Democracy for sponsoring our Yearbook for 2007.

and international studies. He
was President of MAKI (School

Student Organization of ONNED) for 3 years (2001-2004) and Secretary of International Affairs and Emigrant Helenism of ONNED (Youth of Nea Democratia Political Party) for 3 years (2004-2007), permanent member in the Executive Committee of ONNED and also member of the Executive board from 2001. He was Vice President of the Youth European People's Party (YEPP) 2005-2007. He worked through a stage program at the National Constitution of Social Security (IKA) for 3 years and currently he works at the Ministry for Workers.



Secretary General: Martin Humer (Junge ÖVP, Austria) grew up in Linz an industrial town about 200 km west Vienna. He currently works as counsellor responsible for home affairs for the Permanent Representation of Austria to the EU. Before this he served as Secretary General of Junge

### /Basic values and Principles

### **Human dignity**

YEPP affirms the inalienable dignity of every human being. We regard every man and every woman as unique, irreplaceable, and free by nature. Every person has the right and the duty to be fully reponsible for himself and his acts. The protection of human rights is inseparably linked with the protection of the rights of ethnic, cultural, and/or religious minorities.

### Society

Each human being within society depends on others. Because they are free, responsible and interdependent, people must take part in the construction of a pluralist society. The family has a central role in such a society.

### Values

Our thoughts and political actions are based on fundamental, interdependent, equally important, and universally applicable values: freedom, responsibility, fundamental equality, justice and solidarity.

### Democracy

We consider that democracy is the only political system supporting and protecting the integral development of the individual. There is no alternative to democracy and the rule of law.

### Economy and social policy

The concept of market economy and competition is central in our approach to the economic life. Together with democracy it makes it possible to achieve freedom through the decentralisation of power. The economic and social systems are inseparably linked to each other according to the principle "as much market as possible, as much state as necessary". We consider that it is vital to ensure social justice and solidarity based on partnership and participation at all levels, non-governmental and governmental, local, national and international.

### Environment

Our concept of man calls for management of the earth with respect for the self-regenerating potential of nature. Protection of the environment and the concept of sustainable development are bound up with that of responsible growth and must be incorporated into every policy, at every level of power. Political, social and economic action must be geared to ensure that all potential is safeguarded for future generations.

### Peace and security

We believe in the need of a common security architecture for Europe to guarantee the peace, stability and freedom of the continent.

### Europe

We believe in the European Union, as it stands for a future of freedom and security, progress, prosperity and solidarity. European Union membership must be available to all countries of the European continent that meet the requirements of democracy, human rights and market economy.


Hand in hand with the enlargement must go further integration. For us there is no alternative to European integration.

### Subsidiarity

We believe in the sovereignty of states which enables them to work freely and as good as they can to ensure the well-being and development of their people and to defend and reinforce the international legal order. This also means, however, that states must share their sovereignty in supranational and international organisations where they cannot take effective action individually. The European Union as a decentralised community of nations and peoples, not as a unitary super state, must take into account local, regional, national and European levels according to the principle of subsidiarity.

### Participation

It is the citizens of the European Union who by their support give it its legitimation. The European Union requires the active participation of European citizens. Europe is not - and cannot be - the affair of governments alone.

### **/YEPP 10th Anniversary and VI Congress** "Agenda Setting in Europe"

2007 will always be a special year for YEPP as the organization celebrated it's 10th Anniversary. Founded in 1997 in Brussels under the leadership of Mr. Fredrik Reinfeldt, current Prime Minister of Sweden, YEPP felt honored to be able to celebrate this anniversary in Sweden, in the presence of the Prime Minister.

In it's 10 years YEPP has developed into the largest youth political organization in Europe. Apart from being active within all the structures of the EPP and the EPP-ED Group within the European Parliament, YEPP is committed in a large number of other international fora where youth policy has a central role. Beside the political work, we are also keen to note the close political and personal friendships and partnerships which have been developed.

It was a big honour for YEPP to be hosted for the VI YEPP Congress by the Full Members Young Christian Democrats (KDU) and the Young Moderates (MUF). Our topic was 'Agenda Setting in Europe'. The Congress took place in Stockholm from 10-13 May 2007.

The welcome dinner was hosted by Mrs. Gunilla Carlsson, Minister for International Development Cooperation and former EPP Vice-President, who stressed the importance of constructive European efforts to fight global poverty.

Mr. Fredrik Reinfeldt, Prime Minister of Sweden welcomed more than 200 young delegates from all over Europe. Prime Minister Reinfeldt presented the efforts of the



















Swedish government in terms of job creation, enhancing opportunities for young people in society and creating an environment where entrepreneurship is thriving. Furthermore, he emphasized the government's ambition to be in the core of the European Union.

Jakob Forssmed, State Secretary, gave a presentation on the work of the four party centre-right Alliance for Sweden. Furthermore, Mr. Wilfried Martens, President of the European Peoples Party honored us with his presence and by his speech at the event. The participants were also addressed by Mr. Mats Odell, Minister for Financial Markets, who gave a speech on how to revitalize the Lisbon Strategy, and proposed steps for Europe to take in order to become the world's most competitive region. Erik

Zsiga, Program Director for Timbro/The Free Enterprise Foundation ellaborated on dynamics which Western leaders could learn from politicians in New Europe. Having just released his book "Goodbye Eastern Europe", he described his experiences of pro-reform sentiment and optimism among political leaders in New Europe.

On 12 May, the Congress was officially opened in the Riksdag (Second Chamber of the Swedish Parliament). Besides electing a new board, the Congress adopted a new political programme for YEPP, 'Tomorrow's Answers Start Today'. Mr. Ioannis Smyrlis, President of YEPP at his speech stated the main goals of the new elected Board. The prior aim for YEPP is to form a complete arsenal of political positions for the major issues that











occupy the citizens of our countries with these issues that greatly affect all Europeans and Europe as a whole. YEPP will introduce political stands on European Union policies concerning youth issues such as the formation of a new employment strategy, while aiming to form concrete political positions on high politics issues (New European Constitutional Pact, Migration Policies, New Neighborhood policy, integrated Defense Policy) as well as other tasks that may occur as key policy issues in the near future.

The congress dinner and the celebration of the 10th anniversary took place in Solna, where the delegates were received by the hosts, presidents Ella Bohlin (KDU) and Niklas Wykman (MUF).

The event was very successful. 10 years of experience, 10 years of learning and evolution, 10 years of networking, 10 years of passion for youth politics and EU policy in general ... we are now more than ever ready for the upcoming years: the Future is ours, the Future is YEPP!

With the signing of the Reform Treaty, the EU exits a two-year long period of uncertainty that was generated by the failure of adopting the Constitutional Treaty. The EPP has constantly worked on the establishment and strengthening of European institutions that would contribute to the formation of a strong Europe, ready to face the challenges of a rapidly changing international system. ### / YEPP Seminar: Rotterdam (NL) 17-20 January 2007

### Proving Europe's worth. Transport the Energy to Drive Europe's Future!

The YEPP seminar, hosted by Full Member CDJA, took place between the 18th and 21st January 2007 in The Netherlands. For transport and especially harbours, Rotterdam is the right setting. The huge harbour, hinterland activities and cross-border logistics make the value of Europe's open borders clear. It therefore proves the worth of Europe.

The first session was hosted by the Port of Rotterdam. Mr. Van der Tak and Van Keulen gave a broad introduction on the variety of assets that are relevant for the future of the port in enlarging the possibilities for the economical development. Besides the national aspect the relevance for a major part of Europe was presented by giving an insight into the transport networks which run in and out Rotterdam.

According to the Port of Rotterdam, particularly two issues are of great importance for the future:

- 1. fasten procedures for spatial building and construction projects, taking into account and with respect to good governance
- 2. reduce the huge governmental involvement of many public stake holders in projects.

The second session was conducted by Mr. Frank van den Heuvel, a trainer from the Eduardo Frei Foundation









(EFF). The related topic was 'energy'. He gave an overview on the different possibilities in coping with energy questions; bio fuels, solar energy, nuclear energy and other resources. Van den Heuvel also opened the discussion on 'Gazpromization';

Between the lunch break - in which participants were offered a boat tour on the river Maas - and the afternoon programme, participants could choose between two working groups: Statutory Reforms or one on the Working Paper and Resolutions.

On the Saturday, the YEPP Council meeting was held. During the Council meeting the working paper 'Proving Europe's worth. Transport the energy to drive Europe's future' was adopted.

Three speakers came to address the Council on Saturday: Mr. Jan van Laarhoven (chairman EFF), Ms. Corien Wortmann-Kool (MEP EPP-ED) and YEPP was also honoured to have former prime minister of the Netherlands Mr. Ruud Lubbers. He gave an introduction into his work and experiences on the issue of sustainability since the 70s.

The seminar was a great success in its content and organisation.

### Working paper on transport

- → The EU should investigate the efficiency of the EU wide transport flows, its needs for main transport routes, from inflow points at its borders (sea or land) and the infrastructure necessary to support freight transport within the EU to the hinterland
- → The EU should invest in cross border logistic systems and appeal to countries to take swift action and not delay these developments. The EU must particularly invest in better infrastructure in Eastern and Central Europe to unlock these countries and stimulate fast routes between sea ports and inland markets
- → To guarantee an efficient mobility and transport system within Europe, these harbour networks must take up a leading role in implementing the concept of "model shift", meaning that the most effective (combination of) mode(s) of transport must be used to bridge the distance between the harbour and the hinterland. This concept of "model shift" also contributes to the development of an environmentally friendly transport system by supporting railway and inland water transport systems.
- → To guarantee good living conditions and to avoid environmental damage around Harbours and transport routes, EU wide measures need to be taken to combat fine dust exposures by cars and trucks, especially diesel-driven vehicles. Vehicles will have to be fitted with catalytic converters and soot filters. This would make diesel-driven cars as clean as today's petrol-driven cars.
- → The European Commission and the International Maritime Organisation should agree upon tighter pollutant emission standards on shipping and the EU should play a world wide role both in researching and advocating this

### / YEPP Seminar: Zagreb (HR) 6-9 September 2007

The Youth of the Croatian Democratic Union (MHDZ), YEPP full member, hosted the YEPP Seminar around the topic of Climate Change in Zagreb, Croatia, 6-9 September 2007. YEPP had the honour to have Mr. Ivo Sanader, Prime Minister of Croatia and the HDZ President addressed the seminar with an opening speech. The Prime Minister reported on the political situation in Croatia as it moves towards Euro-Atlantic integration. Speaking about climate change, Mr. Sanader emphasised the need of implementing comprehensive measures to address the challenge of global warming and concluded that it can only be done through international cooperation at the global level.

The participants were also addressed by Mr. Bozo Biskupic, Minister of Culture and HDZ International Secretary at the welcome dinner and, during the seminar, by H.E. Vincent Degert, Head of Delegation of the European Commission to Croatia, speaking about the EU policy related to climate change, Mr. Nikola Ruzinski,

State Secretary for Environmental Protection and member of the Negotiating Team for the accession to the EU, who gave the presentation on what society can do to limit the effects of climate change, Mr. Vladimir Paar, academician and member of the Croatian Academy of Art and Science, spoke about the human and scientific responsibility for the climate change, Mr. Ante Curkovic, Professor at the Faculty of Electrical Engineering and Computing, indicated the importance of the development, of research and use of the renewable energy and Mr. Kreso Pandzic, Assistant Director at the Meteorological and Hydrological Service, focused on the effects of the global warming on life on Earth.

Furthermore the first meetings of the Permanent Working Groups on European Affairs and Intergenerational Justice took place, which were followed by Working Groups on the working paper and the resolutions. These meetings were following by the YEPP Council meeting.

### Working paper on Climate Change

### The Politics of Globalisation

YEPP recognises the chief responsibility which must be borne by developed industrial nations to 'lead the way' in the fight against global warming. European nations must therefore "set this issue an as an overarching priority and to speak with a single European voice."

Considering the multilateral approach to climate change adopted by Member States, the EU must continue "constant dialogue" with those developed nations who continue to refrain from ratifying the Kyoto Protocol in order to achieve a common global consensus and partnership in this most important of issues.

Developing countries also have responsibilities to undertake their contribution to reducing the rate of global warming - in this regard the use of "green diplomacy" by the EU and other developed countries is a key strategy which must be employed. The linking of economic cooperation and development cooperation to global climate change objectives must be the way to achieve global objectives on climate change.

### The Strategy Going Forward

We must focus clearly on the targets being set for GHG emissions reductions over the next fifty years. YEPP is committed to the full realisation of the following targets:

- → overall emission reductions for all industrialised countries of 30%, in comparison with 1990 levels, by 2020
- increase the share of renewable energy sources to
- → to obtain a 60-80% reduction in emissions, as compared with 1990 levels, by 2050

The need to combat the problems with "carbon leakages" inherent in the ETS system.

Incentivising environmental technologies.

The need for greater interdepartmental cooperation within European public policy in achieving climate change objectives - "so that...industrial policy and transport, agriculture, research and development and other initiatives are better coordinated with climate change targets.

Noting the significance of the decision by the European

Council of Ministers to include statistics on aviation emissions within the reduction targets after 2011.

Considering the exponential expansion of air-travel in Europe, YEPP calls on immediate action to be taken to reduce carbon emissions drastically from this form of transportation. Unless immediate action is taken on this point, progress made in other areas of emissions reductions will be less meaningful.

### **Energy and Climate Change**

As developed nations our reliance on electricity and other forms of energy is in extricably linked with our emissions problems. YEPP calls for the urgent deployment of renewable energy and environmentally friendly technologies.

Investment in the most modern forms of electricity transmission as well as in new electricity grids must be a priority in the objective to achieve greater energy efficiency.

Tariffs on energy efficient products must also be removed.

YEPP also recognises the individual responsibility of all citizens to be conscious of their contribution as consumers to carbon emissions and energy efficiency. A citizenry which is conscious of the gravity of environmentally unfriendly energy must be prepared to pay a premium for renewable energy.

### / YEPP Seminar: Ljubljana (SI) 6-9 December 2007

The YEPP seminar on Demography was organized 6th-9th December 2007 in Ljubljana, Slovenia and was attended by 73 representatives young politicians. It was organized jointly by three youth organizations of Slovenian members of the European People's Party (SDS (Slovenian Democratic Party), NSi (New Slovenia) and SLS (Slovenian People's Party)) - SDM (Slovenian Democratic Youth), MSi (Young Slovenia) and NG SLS (New Generation), all three being full members of YEPP.

The first evening of the seminar, a welcome dinner reception for participants was hosted by Mrs. Ljudmila Novak, MEP. The conference was officially opened on Friday morning by the president of YEPP Mr. Smyrlis, and the presidents of the three hosting youth organizations - Mr. Robert Ilc (MSi), Mr. Nikolaj Oblak (SDM) and Mr. Rok Ravnikar (NG SLS).

Afterwards the conference continued with the presentation of Professor Mrs. Jana Bezen\_ek, who introduced the topic. She stressed that it is crucial for our societies to establish such conditions, which will encourage young families to have children, if we wish to turn around the negative demographic trends in Europe.

After the introduction and discussion, the participants were adressed by Mr. Janez Podobnik, Minister of the Environment and Spatial Planning and Vice President of the Slovenian People's Party (SLS) and Mr. Primo\_Pirc, the Director of the Slovenian Housing Fund. They focused mainly on those aspects of demography, which are influenced by spatial planning (housing for young families,...). Minister Podobnik stressed in particular certain incentives that have been put in place for young

families. The goal of the government housing policy in Slovenia is to enable housing security for as wide a circle of Slovenian citiziens as possible.

On Friday afternoon, the panelists were Mrs. Marjeta Cotman, the Minister of Labour, Family and Social Affairs and Mr. Davor Dominku , Director General of the Directorate for Social Affairs at the Ministry of Labour. Family and Social Affairs. Minister Cotman stressed the importance of the choosen topic, especially for the young generation, which will have to deal with the consequences of demographic changes in Europe. She also pointed out certain priorities that Slovenia will deal with in this regard, also during the Slovenian EU Presidency in the first half of 2008. Mr. Dominku further explained some examples of Slovenia's efforts to stop the negative demographic trend, pointing out the successful reduction of youth unemployment, which contributes to better social security and can consequently also contribute to a better demographic trend.

After the presentation, conclusions of the day were made and the participants invited to a sightseeing tour of the cave "Postojnska jama". After the tour, the YEPP Board returned to Ljubljana for their scheduled meeting, while the other participants enjoyed a typical dinner in the Stanjel castle in the Karst region.

On Saturday morning, there were meetings of YEPP working groups, where participants discussed the draft working paper on demography and the proposed resolutions.

Before lunch, there was also a presentation of the upcoming Slovenian EU Presidency by Mr. An\_e Logar, M.Sc., the Director of the Government Communication Office. He listed some priorities, namely: the ratification of the Lisbon Treaty, EU enlargement and Western Balkans, EU Neighbourhood Policy, Energy Policy, Intercultural Dialogue and the Lisbon Strategy.

The lunch in the hotel was held in the presence of Mr. Milan Zver, Ph.D., Minister of Education and Sport and Vice President of the Slovenian Democratic Party (SDS). Minister Zver pointed out the importance of such conferences, as they represent a further means of cooperation between youth from all over Europe and are important for the exchange of good practices.

After lunch the participants attended the YEPP Council Meeting, during which they adopted, with minimum amendments, the draft working paper on demography, entitled "Demography: our common challenge" and several resolutions.

After the Council Meeting, participants had the choice of attending the YEPP basketball match or going for a sightseeing tour of Ljubljana.

In the evening, the goodbye dinner was held in a scenic restaurant near Ljubljana, where the participants could choose from a variety of typical Slovenian dishes. The dinner was attended by Mr. Lojze Peterle, MEP and Vice-President of the EPP, who welcomed everyone to Slovenia and together with the hosts, taught the participants to dance some Slovenian traditional dances!

### Working paper on demography

Demography is a crucial topic which is on the table in all Member States, as all our societies and economies will have to face future evolutions, due to this worrisome demographic situation. In the document, YEPP welcomed the inclusion of this issue into the priorities of the EU trio presidency programme (German, Portuguese and Slovenian presidencies of the EU). The role of YEPP was stressed in taking an active stand and putting forward certain concrete proposals, which could prove useful in tackling this challenge. The aim was not to find one solution to the problem, but rather to present some factors, which are perceived as having an impact on demographics and propose some solutions, which could serve as guidelines for policy-makers. Below are listed only the main ones, for more see www.yepp-eu.org:

- → The FAMILY as an institution deserves our special and concrete support, so that balancing work and family life would be easier for both women and men.
- → Authorities must be aware of the need to facilitate suitable HOUSING for young families.
- → We must strive to improve the availability and access to CHILDCARE FACILITIES.
- → SOCIAL SECURITY SYSTEMS have to adapt to the new challenges but at the same time retain their solidarity and viability.
- → Some of the most crucial proposals are related to the PARTNERSHIP BETWEEN GENERATIONS. This partnership is very valuable to us and in this regard, we stated that PENSION systems need to be revised and the LABOUR MARKET needs to undergo certain changes, in order to keep social security systems financially viable in the long run and maintain them as socially acceptable.
- → Reforms of our education systems must continue, if we wish to make them more flexible and efficient. Our political family has been tackling these issues for some time already, either through policies of our national governments, our party manifestos, through the EPP, the EPP-ED group in the European Parliament or various events at an expert level. We are aware how important it is to tackle them promptly and efficiently, if we are to continue to live in an area of peace, prosperity and solidarity. We therefore invited the EPP to be even more proactive in this regard and again urge its members to act nationally in favour of such policies, which aim to improve the demographic situation in Europe.

### / YEPP Summerschool: Limassol (CY) 27 June - 1 July 2007











The Summer School of the Youth of the European People's Party (YEPP), took place between the 27th of June and the 1st of July 2007, in the city of Limassol in Cyprus. 53 participants, from different European countries, attended the event, which was hosted by YEPP's full member, the Youth of the Democratic Rally (NE.DI.SY). The event was based at the seafront hotel, Kanika Pantheon.

The topic of the summer school was: "European Neighbourhood Policy. The Case of the Middle East". It is beyond dispute, that several problems, which the EU is faced with, (illegal immigration, racism, xenophobia), are related with the long lasting disputes in the Middle East. In the framework of the YEPP Summer School, the participants, discussed measures, which could lead to a comprehensive European policy for the bloodstained Middle East.

### /YEPP Working Day: Brussels (BE) 31 March 2007

YEPP was dealing with major dossiers in 2007. During the council meetings in Bruges (Belgium) and Rotterdam (The Netherlands), all YEPP Members therefore decided to gather once more for preparatory work ahead of the YEPP Congress that took from 10-13 May in Stockholm, Sweden.

This day consisted of several workshops. The aim was to finalize the statutory reform and the discussions on the draft new YEPP Political Program took place. A draft version of the political program was sent out before the meeting in order to receive in advance amendments.

The working day took place at the CD&V Headquarters and around 75 representatives were present.

### / Permanent Working Groups

In the beginning of 2007 YEPP continued her efforts of the work that started in 2006.

We have concluded a financial reform, that was necessary for guaranteeing the future of YEPP, as well as a Statutory reform which was needed. Furthermore the need for a new political programme was underlined. The work was done in different working groups that took place during the seminars. The conclusions where approved and concluded during the Congress in Stockholm in May 2007.

### Working Group on Political Affairs

Working Group I, chaired by First Vice-President Robert Golanski and Vice-President Jeroen Vanden Berghe, focused on the Rome Manifesto of the EPP, the YEPP seminar working papers and the resolutions. It was also the forum where the next political program was prepared. Based on the values and principles all YEPP member organizations share, but tailored to the expectations of future political generations. The document invigorated the political debate between the member organizations, but will also set the political framework for the upcoming YEPP Board 2007-2009.

### Working Group on Financial Reform

The difficult economic situation of YEPP urged the organization to undergo a thorough financial reform. The strongest contributing factors to the difficulties were an increased level of activity and the rise of the amount of members.

### Working group on the Statutory Reform

This Working Group was chaired by vice-president D. Cermak and Deputy Secretary General H. van Rossum. The working group focused on the process to adjust the YEPP statutes from the current situation and be of service for the future. YEPP recognised that through the growth of the organisation certain adjustments in the statutes had to be made. The goal to reach is to establish a statutory reform that can serve the functioning of YEPP in the upcoming years.

After the Summer of 2007 the new board introduced two new permanent working groups.

### Working Group on Intergenerational Justice

YEPPs political program has introduced our high interest on reforming Europe's society and economy and to have the right and convincing answers not only to the fellows of our generation. Demographic change, with continually lower birth rates, is leading to a Social Security system where the needs of the older generation must be met by an ever-smaller group of wage earners. At the same time the burden of taxes and repayment of state debt are falling on ever fewer shoulders.

The aim of the Working Group on Intergenerational Justice which is chaired by Thomas Schneider, First Vice President, and Laurent Schouteten, Vice President, is to take demographic change and intergenerational justice as a special concern of our work. We see intergenerational justice and sustainability not only as principles of environmental policy, that is of course a main point, but also as part of social and financial policy
